- 6. State and National Dues** — Includes membership in NDU, NEA and AFT. State dues include a \$1 assessment for the NDU Foundation; an assessment to market public relations (Active \$7, Retired, \$7, and Student, \$1) and a \$1 assessment for the NDU Disaster Relief fund.
- 7. United PAC**—A \$10 contribution to United PAC is included as part of the "Every Member Option." A member may contribute more than the amount printed. A member not wishing to contribute to United PAC should initial the appropriate statement.
- 8. NEA FCPE/United PAC**—The NEA Fund for Children and Public Education (NEA FCPE) and the United Political Action Committee (UPAC) collect voluntary contributions from Association members which are used for political purposes, including, but not limited to, making contributions to and expenditures on behalf of friends of public education who are candidates for federal, state and local office. Only U.S. citizens or lawful permanent residents may contribute to these funds. Contributions to these funds are voluntary, making a contribution is neither a condition of employment nor membership in the Association, and members have the right to refuse to contribute without suffering any reprisal. A member may contribute more or less than the suggested amount, or may contribute nothing at all, without affecting his or her membership status, rights or benefits in NEA, NDU, AFT or any other affiliates. Contributions to these funds are not deductible as charitable contributions for federal income tax purposes. Federal law requires to use our best efforts to collect and report the name, mailing address, occupation, and name of employer for each individual whose contributions aggregate in excess of \$200 in a calendar year. Should I choose to make an additional contribution I understand that I am making a joint contribution to the NEA Fund and United PAC and that 20% of my contribution will be given to the NEA Fund and that 80% will be given to the United PAC.
